

T-Systems International GmbH (“T-Systems“) engaged EY GmbH & Co. You have asked T-Systems to provide you with a copy of EY’s final T-Systems Service Organization Controls 3 (SOC 3) Report *Report on Open Telekom Cloud system provided from the data centers in Germany and in the Netherlands relevant to Security, throughout the period 1 January 2023 to 31 October 2023*, dated 3 April 2024 (the “Report”) EY prepared pursuant to the Agreements.

You have now requested EY to agree to the disclosure of a copy of the Report exclusively prepared for T-Systems on the basis of the Agreements to you as a third party (“you” or “Recipient”).

The Report is solely based on the above mentioned Scope, except where a more limited Scope is specified in direct or indirect connection with the respective Report.

EY only agrees to the disclosure of the Report to you if you acknowledge and confirm the conditions as outlined below. The parties agree that neither this agreement nor the disclosure of Report does imply or constitute a client relationship between you and EY.

In preparing the Report, EY did not and could not take into account any specific requirements that you may have; therefore, to the extent that such requirements differ from those of T-Systems as set out in the Agreements they were not required to be dealt with in the Report and accordingly, EY may not have addressed issues of relevance to you.

The Report reflects information as of 3 April 2024. You acknowledge and confirm that EY accepts no obligation to update the Report or to provide us with any future updates of the Report. Material events may therefore have occurred which are not reflected in the Report.
